4. Standing Committees' Reports and Business

4.1. Facilities & Displays

4.1.1. Awards

 The recommendations from September 5, 2014 Sports Heritage Committee meeting were discussed.

Decisions: The Athlete and Builders (18) will each receive an 8 $\frac{1}{2}$ x 11 plaque which will consist of their Black and White head-shot, Coloured SSH Logo and short Bio affixed to a mounting composite plaque. The Board will retain a printed copy of this image but will **not** have it mounted (**note this change from previous recommendations**). These images will be displayed that evening on the "roller blind" banners (see below) and be part of the AV presentation

Teams- Three of the four Team members will receive a folder containing a picture of the team. **The Curling team** will be an exception in that the Elmvale Curling Club has donated money to have that team's picture mounted in a plaque format.

The Board will retain a copy of these Team images. Their display for that evening will be as outlined above for Athletes and Builders.

APPENDIX B

Financial Procedures for Springwater Sports Heritage

All financial policies currently approved by Springwater Township will be followed and adhered to by Springwater Sports Heritage. Any amendments and/or new financial policies that are to be adopted by Springwater Township will also be adhered to by the Springwater Sports Heritage Board.

Annual Budgets – Annually the Springwater Sports Heritage Treasurer will assemble and present a proposed annual budget & business plan to the Board of Directors for discussion and approval. The Board of Directors and Standing Committee Chairpersons will have significant input into the development and direction of the budget & business plan based on priorities set out each year. The approved budget must be a balanced budget with no projected deficit. At the end of each fiscal year the actual surplus/deficit will become the opening balance for the next year's budget. The annual budget & business plan shall be discussed and approved by no later than August/September each year. Once approved by the Board of Directors the Treasurer will forward a copy to the Township of Springwater Director of Finance by no later than September 30th each year in order for it to be considered in the Township's Annual Budget & Business Plan.

Reporting Period – The reporting period is from January 1 to December 31 each year. **Regular Reporting** – As part of each Board meeting a financial report will indicate the current cash position, the inflows and outflows for the reporting period and any outstanding expenses or receipts. Copies of the report will be made available to all board members. It is the duty of each director to ensure that they review and understand the financial reports that are provided. The report will be the official report provided by the Township.

Signing Authority –All purchases must be presented and approved by the Board of Directors prior to the purchases being made. Once authorized approval is discussed/completed a notice (invoice) will be communicated to the Township Finance Department Liaison by the Sports Heritage Treasurer and/or Designate. If payments are required prior to Board approval an email of agreement from the Sports Heritage Treasurer and/or Designate, along with the Chair of the Board should be sought and then a discussion will take place at the next Board meeting to ensure appropriate approval of expenditure. When an invoice is received by the Township Finance Department an email will be sent to the Springwater Sports Heritage Treasurer and/or Designate for final approval prior to payment being made. All invoices shall be addressed to the Township of Springwater c/o Springwater Sports Heritage.

Expenditures and Capital Purchases – All expenditure purchases will follow the Township's current "Procurement By-law" including standard purchases, competitive bid processes and gifts in-kind. The Township work flow process related to payments or procurements should be followed to ensure timely payments and accuracy. All cheques for approved payments will be issued by the Township on behalf Springwater Sports Heritage.

Cash Transactions – All cash transactions should be avoided if possible. If cash transactions should be required for any function a clear process for collection and deposit of funds should be discussed at the Board. If cash transactions are required there should be at least 2 people present when cash is being handled. Once all cash has been counted it shall be locked up in a location that can only be accessed by authorized individuals (Treasurer and Designate). Deposits shall be completed as soon as possible with the Township after the event occurs. Deposits are to follow the Township's Cash Deposit Policy & Procedure.

Credit Cards - All credit card transactions should be avoided if possible. If credit card transaction should be required for any function a clear process for collection and deposit should be discussed at the Board.

Income Tax Receipts – Prior to the issuance of any income tax receipts the Township Director of Finance shall be consulted.

Deposits – All cheques/cash/credit card payments to Springwater Sports Heritage will be made to the Township of Springwater Administration Centre payable to "**Township of Springwater**" It should be clearly noted that the deposit be made to Springwater Sports Heritage account.

Chart of Accounts – The chart of accounts are provided by Springwater Township. Additional reporting/categorizing by specific function may be required to assist the Board in summarizing revenues and expenses.
