Induction

2020 was to be Springwater Sports Heritage's 4th Induction but COIVID19 had other plans for the 2020 Induction.

It was decided by the board to put the 2020 Induction on hold and we would have a 2021 Induction to be held at Snow Valley Ski Resort on Friday September 24, 2021. Nominations for the 2020 Induction would be carried over to 2021 and the deadline for nominations for the 2021 Induction would be March 31, 2021. The following induction would then take place in 2023.

A promotional piece to let people know about Springwater Sports Heritage and the 2020 Induction was put in Patrick Towne's column in the Springwater News. The hope was to get people to nominate worthy candidates for the induction. We did receive some nominations from across the township.

Several areas of the induction process were discussed at an Induction Ad Hoc Committee Meeting early in 2020 to hopefully make the Induction process better and the Induction night even more memorable. Hopefully for the 2021 Induction, we hope to have a digital submission option available. Also the hope of online payments for the induction will be available and the we talked about doing away of the ticket that is required.

As for the night of the induction, speech guidelines will be developed and a tighter timeline for the night to allow for some post Induction social time. Also we would like to maximize Inductee/Alumni attendance.

We hope to be busy in 2021 in preparation of the event, as long as COIVID 19 allows us.

Technology Committee 2020 Annual Report

The Technology Standing Committee is comprised of Larry Simpson (Chairperson), Faye Stone and Website Advisor Brenda Stanley. The Committee has access to a range of resource personnel to support them when and where necessary. Currently the following are available to assist with the website as required: Sue Adams (technical), Keith Columbus (Graphics), Mary Fleming (Proof Reader), Ken Flieger (technical), Tim Ritchie (technical).

During 2020 the Technical Committee continued, somewhat constrained by Covid-19, with its prime objectives of Filter Development and the integration of Multimedia into the Galleries section of the Website. In addition to the required ongoing maintenance and upgrades the Committee spent the majority of its time focussing on these two sizable and vital development objectives. The Filter approach is consistent with the majority of websites in use today. It allows the user to quickly focus in on their individual interest(s) while envisioning the opportunities of the bigger picture.

While working through the Filter/Galleries development the websites navigation system was modernized to included rollover dropdown menu items as well as the needed and appropriate flare outs. These upgrades, to the navigation system, provide a quicker, observable and beneficial prompting options. It's expected these improved navigation tools will significantly assist the website users.

A substantial amount of time and thought was devoted to the selection of headings, categories and individual elements within each of the Filters. It was seen as important to minimize the number and avoid duplication while ensuring all potential options were encompassed. Although the Committee is comfortable with their choices the opportunity remains to add additional categories and/or elements should it become appropriate in future development. The balance between firmness, flexibility, the website user and future development was always a conscious consideration.

A major genesis, to this significant development, was a result of the opportunity of having access to two SSH Athlete Inductees (Corby Adams and Homer Barrett) private collections of a vast treasure trove of material related to their outstanding and successful sporting careers. The assortment and scope of their diverse media highlighted the complexities and potential options. Although a challenge, it proved to be a guiding light once the intricacies and enormity was revealed. Though both projects are not yet uploaded the Committee is confident the development has established a solid foundation for these and future media projects to be successfully accessed, displayed and archived for SSH website users.

In early fall the Board was given the opportunity to provide their feedback on the development of the Filters/Galleries. Their feedback was somewhat positive but focussed more on the "Website Search Component" that has not been fully researched or scoped out to date. It may prove beneficial to establish a "Focus Group" to fully investigate the Filters/Galleries development accomplishment and deficiencies. This approach should reveal any necessary adjustments and provide possible future expectations and directions to be undertaken.

During 2020 the Technology Committee joined forces with the SSH Induction and Finance Committees and the Springwater Township Finance Department to commence the establishment of an online payment system to support the ticket purchases of SSH's Induction Ceremony. Early in 2021 the Committees will commence the necessary final steps and adjustments to ensure the 2021 Induction Ceremony attendees have the option of purchasing their tickets online. It's expected ticket sales will be tracked online and reports will also be available as required. This option will add a minor cost to the expenditure side of the ledger but will provide a service that many previous ticket purchasers wished to have. At this point it will still be necessary to determine if the 2021 Ceremony will proceed because of the virus.

Notable Future Development Considerations

- A potential <u>WEBSITE SEARCH COMPONENT</u> is likely the next major improvement/development that should be undertaken. A Search tool may benefit website users if they are looking for something specific. Springwater Sports Heritage usually is at the top of Google searches given that we have now established ourselves. Different options will need to be considered. Using "Google Site Search" to focus on the SSH website appears, at first glance, to be a very good cost/benefit option. Further review and input will be appropriate prior to determining the most desired route.
- Given the broad respect and appreciation SSH has been able to create
 within the community it would be prudent to include a
 BEQUEST/LEGACY opportunity for interested/potential benefactors.
 This would obviously assist in financially sustaining SSH while
 providing a means for thoughtful patrons to be recognized and
 support a valued community asset.

- SSH has been offered a physical location in the pending Springwater Township Community Hub and over its seven years SSH has received consequential offers of SPORTING MEMORABILIA from thoughtful donors. It's expected the Technical Committee will support, where appropriate, the Facilities Committee as they undertake this indispensable endeavour to display, honor and preserve Springwater's sporting memorabilia. The Technical Committee has a significant role to bring forward the value that technology can play in ensuring the modernization of both these physical and virtual opportunities. The digitation of the memorabilia can well serve the website, kiosks and the Community Hub.
- Throughout the development of the website a variety of adjustments were made, some items deferred and alternative means envisioned. The need to undertake a <u>WEBSITE ORGANIZATIONAL UPDATING</u> to ensure administrative and logistical support is enhanced needs to be undertaken. Process, procedures, duplication and archiving all require thoughtful and timely attention. One key example of needed change is the ongoing administrative digital documentation, such as email, being appropriately recorded and archived for current and future use and to meet legal obligations. The longer this requirement is pushed forward the greater the challenge will become.
- The current <u>VIDEO ASSETS</u> require organization and must include supportive opportunities for growth. With the evolution of the ability for videos to be recorded on smartphones and tablets, SSH needs to create clear and uncomplicated pathways for the appropriate videos to become part of the website, kiosks and Community Hub.
- The usefulness of having <u>STRATEGICALLY LOCATED KIOSKS</u> has unconsciously been overlooked. The value of expanding the content, locations and revenue generation is evident and should be undertaken. It will provide numerous meaningful benefits while creating a much greater public awareness. Raising SSH's community profile and encouraging individuals to provide their assets will be a win-win.
- ONGOING GROWTH AND MAINTENANCE will continue. As new technology becomes available SSH must become aware of its potential applications and how it could positively affect SSH's direction. The Technical Committee is responsible for keeping the Board informed and following up on any Board requests for support. The Committee is also responsible for supporting all of the SSH Standing Committees.

It's expected that an active Promotion Committee will substantially expand SSH's social media activity and will require ongoing support of the Technical Committee.

Website Activity

Springwater Sports Heritage's website is in reality SSH. Tracking the website's user activity is essential and it provides detailed statistical information to assist in determining if the website is meeting its stated purposes. This metric assists in providing an objective measurement to emphasize the website's value, usage and growth

The following chart quantifies the website activity from 2015 to 2020. Once again SSH is very pleased to acknowledge its continued expansion of user access.
