2022 Year end Summary

Induction 2021

Our 2020 Induction was cancelled as a result of COVID19. It was decided to extend the deadline for nominations to April 30, 2021 and hold the induction in the fall of 2021. COVID19 interrupted those plans as well as many restrictions in the province came into place with limits on gatherings. We did receive a few more nominations during the extended period.

During May and June of 2021, the nominations received were individually reviewed and ranked by each board member. A meeting was then held in July of 2021 to vote on the nominations. The plan was to promote the inductees through social media. The following were nominated to be inducted into our 2021 class that would be ceremoniously inducted in the spring or fall of 2022.

It is now our hope to induct these 2021 Inductees in the fall of 2022. A tentative date of September 23, 2022 has been set at Snow Valley Resort. Hopefully restrictions have been lifted for indoor gatherings. The plan is to have ticket sales online and availability to purchase tickets online.

Immediately following our 2022 induction, we will open up nominations for our 2023 Induction to be held in the fall of 2023. By this time we hope to get back to having inductions every two years.

<u>Technology Committee 2021 Annual Report</u> <u>Springwater Sports Heritage</u>

Foreword

The 2021 Technology Standing Committee was comprised of Larry Simpson and Faye Stone. In addition to the committee members Brenda Stanley, of "Heart of Business", once again continued to provide prudent advice as well as volunteering a significant amount of "off-the-clock" personal time to assist with design modifications and inputting.

Unfortunately, much of the desired and planned development was unable to be achieved as a result of Larry taking on a major healthcare provider role. Throughout the year the absolute necessary fundamentals and commitments were fulfilled but a considerable amount of hoped for progressive improvements were left unfinished. This report will outline what was achieved and what potential development and ongoing activity could/should be addressed.

2021 Achievements

The primary development for 2021 was to establish an affordable website "**Search Component**". Following the Technical Committee's 2020's focus on the development of a "**Filter Methodology**" for the website some Board Members requested the addition of a search function. Throughout the year development took place and the website now has its initial search function. The Technical Committee is anticipating relevant feedback on the search development and will follow-up with any further appropriate modifications/development. It's important to note the difference between the power of the major search engines that are universally use on a daily basis and one designed on a much smaller scale for specific websites.

Activity undertaken/completed Summary

- Website Development
 - A **Search component** was developed and added as per above.
 - Expanded **gallery fields** to further permit additional and multiple options for location, year, and sports categories when applicable.
 - Created a system to allow a way to batch upload images and establish/update the image fields as required
 - Provide a way to **set fields** during the upload process
- Faye & Mike Stone reviewed, identified added missing names and relevant comments/information to the **2018 Induction Photos**
- 2021 Hall of Fame Nominations were organized to received in a **digital format** although expected formatting and clear identification was not always what was expected

- Seventeen **2021 Inductee Nominations** were assembled/adjusted and loaded to the website to allow the Board Members access and the opportunity to review and rank to complete the 2021 inductee selection process.
- Added 15 timely news items to the website
- Sadly, five more outstanding Inductees were added to "In Memory". Given the Covid restrictions in place the **Banners** are not being used at the passing Inductees' viewings and services.
- Website access and security tweaked and upgraded

Going Forward

The website represents Springwater Sports Heritage's implicit manifestation and expanding annals. It's imperative that design, utilization and growth receives timely and keen consideration. Future expansion and adaptions must reflect the changing need and opportunities. In addition to the "big picture' a multitude of distinct additions, modifications and outstanding desired supplementary elements can and should be considered. As Rome was not built in a day nor will SSH's website reach its many desired fundamentals in the short term. The following unranked and unprioritized identifies a large number of items to consider and move forward through 2022 and beyond with a common expectation.

- Upload the 2021 Inductees' **plaques** and **profiles** when completed
- A **budget** has not been established for any 2022 activity
- Conclude Homer Barrett's gallery project
- Add **Corby Adams'** gallery material Trish has prepared when satisfied with "Search Component"
- Establish SSH email addresses for Board and Committee Members
- Complete and test **online payment** project in time for next induction ceremony
- Further enhancement of **online forms**
- Establish protocols and undertake **archiving** of SSH's activity
- Arrange to increase the size of the Technical Committee with new Members
- Digitally record/document and upload sporting **memorabilia** to website when memorabilia protocols and definitions are developed and approved
- Complete "Sundry Media" cleanup of current material and prepare to promote/add additional material
- Address issues with videos and YouTube
- Reposition **Patrons** to further emphasize their value to SSH on all devices
- Mitch to recommend what can be done with his George Allan Project
- SSH to establish **Bequest/Legacy** opportunities and promote on the website
- Given their importance an Alumni web presence could to be established
- Interact/coordinate any technical matters/opportunities with Community Hub project
- Purge/Organize website administrative "Backend" to assist approved users
- Monitor innovative technical trends that could improve and enhance the website

- Mr Johnston's video needs to be approved, modified if required and added to Heritage
- KIOSK
 - o Update arena kiosk as it has not been attended to since the commencement of Covid
 - The **administrative backend** requires purging and organizing
 - o SSH should have access to modify middle panel (timely announcements)
